1. The shipment volume of handset lens sets decreased by 26.4% YoY, which was mainly due to the current weak demand from the overall smartphone market.
2. The shipment volume of vehicle lens sets increased by 47.4% YoY, which was mainly due to the low base caused by the shortage of the key components in the auto supply chain in the same period of last year.
3. The shipment volume of handset camera modules decreased by 23.4% YoY, which was mainly due to the current weak demand from the overall smartphone market; It decreased by 21.0% MoM, which was mainly due to the high base caused by stocking demand from an individual customer last month.
