On 11 November 2010, the Company entered into a modification deed (the “Modification Deed”) with 深圳市投資控股有限公司 (Shenzhen Investment Holdings Company Limited*) (“SIHCL”) to amend the terms of the convertible bond, which includes, among other things, the adjustment of the conversion price from HK\$1.20 to HK\$0.78. The conversion of the principal amount of HK\$1,727,500,000 in full at the said revised conversion price of HK\$0.78 was completed on 29 December 2010, and 2,214,743,589 new ordinary shares of the Company were issued accordingly.
