The Board wishes to inform the shareholders and potential investors of the Company that the consolidated annual results of the Company for the year ended 31 December 2008 are expected to be adversely affected.

Shareholders and potential investors of the Company are advised to exercise caution when interpreting the expected financial result described in this announcement and when dealing in the securities of the Company.

This announcement is made by order of the board of directors of China Mining Resources Group Limited (the “**Company**”) pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

Reference is made to the annual report of China Mining Resources Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) for the year ended 31 December 2007 (the “**2007 Annual Report**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders and potential investors of the Company that the consolidated annual results of the Company for the year ended 31 December 2008 (the “**2008 Annual Results**”) are expected to be adversely affected.

The Board announces that the expected loss in the 2008 Annual Results was due to the following:

- (a) the significant decrease in the price of commodities relevant to the business of the Group have led to the significant decrease in both turnover and profit of the Group; and

- (b) taken into consideration the decrease in commodities prices, impairment provisions will be made on intangible assets, namely the mining rights, of the Group, which may significantly affect the 2008 Annual Results.

This profit warning and the information contained in this announcement are based on the preliminary assessment of unaudited management accounts by the management of the Group. The audited consolidated financial results of the Company for the year ended 31 December 2008 are yet to be finalized.
