## **Election of Means of Receipt and Language of Corporate Communications**

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the amended and restated memorandum and articles of association of Yixin Group Limited 易鑫集团有限公司(the "Company"), the Company is making available to you certain options for receipt of future corporate communications of the Company ("Corporate Communications"), which means any document(s) issued or to be issued by the Company for the information or action of any holders of its securities, including but not limited to: (a) directors' reports, annual financial statements together with the independent auditor's reports and, where applicable, summary financial reports; (b) interim reports and, where applicable, summary interim reports; (c) notices of meetings; (d) listing documents; (e) circulars; and (f) proxy forms.

You may choose one of the options set out below:

Option 1: to access all future Corporate Communications through the website of the Company at www.yixincars.com

(the "Website Version") instead of receiving printed copies by mail; or

Option 2: to receive by mail the printed English version of all future Corporate Communications only; or Option 3: to receive by mail the printed Chinese version of all future Corporate Communications only; or

Option 4: to receive by mail both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends that you elect Option 1 above to receive the Website Version of all Corporate Communications in future.

If the Company does not receive the reply form duly completed and signed by you or does not receive a response indicating an objection from you by April 10, 2024, you will be deemed to have consented to receiving the Website Version instead of receiving printed copies of all future Corporate Communications and a written notification of the publication of the relevant Corporate Communications on the website of the Company will be sent to you either by post or by email in the future.

You have the right at any time to change your elected means of receipt and choice of language of the Corporate Communications by providing reasonable prior notice in writing (not less than 7 days) to the Company c/o the Branch Share Registrar or by sending an email to <a href="mailto:yixin.ecom@computershare.com.hk">yixin.ecom@computershare.com.hk</a>. If for any reason you have difficulty in receiving or gaining access to the Website Version of the Corporate Communications, the Company will, upon your request in writing or by email, promptly send the printed version(s) of the Corporate Communications to you free of charge.

Please note that (a) the printed versions of the Corporate Communications in English and Chinese will be available from the Company or the Branch Share Registrar upon request; and (b) the Website Version of both English and Chinese of the Corporate Communications will be available on the website of the Company at <a href="www.yixincars.com">www.yixincars.com</a> and on the website of the Hong Kong Exchanges and Clearing Limited at <a href="www.hkexnews.hk">www.hkexnews.hk</a>.

## 選擇公司通訊之收取方式及語言版本

根據香港聯合交易所有限公司證券上市規則第 2.07A 及 2.07B 條及 Yixin Group Limited 易鑫集团有限公司 (「本公司」) 之經修訂和重述的組織章程大綱及章程細則,本公司將向 閣下提供若干方案,以供選擇收取本公司日後之公司通訊(「公司通訊」),即本公司刊發或將予刊發以供其任何證券持有人參照或採取行動之任何文件,包括但不限於: (a)董事會報告、年度財務報表連同獨立核數師報告及(如適用)財務摘要報告; (b)中期報告及(如適用)中期摘要報告; (c)會議通告; (d)上市文件; (e)通函; 及(f)代表委任表格。

閣下可選擇以下其中一種方式:

方案 1: 瀏覽所有日後在本公司網站 www.yixincars.com 登載之公司通訊(「網上版本」),以代替以郵寄 方式收取印刷本;或
