The Change Request Form may also be downloaded from Yuexiu REIT’s website. (“Corporate Communication(s)” include(s) any document(s) to be issued by Yuexiu REIT for your information or action, including but not limited to, the annual report\*, the interim report\*, a notice of meeting, an offering document\*, a circular and a proxy form. Save for the documents marked with an asterisk(\*), the Corporate Communications will be produced in both the English and Chinese languages and the unitholders will accordingly receive a printed version in both language versions regardless of their choice.)

Both the English and Chinese language versions of the Corporate Communications are available on Yuexiu REIT’s website for at least 5 years from the date of first publication.
