**Election of Language and Means of Receipt of Corporate Communication**

In order to reduce costs and the environmental impact of distributing documents to unitholders, Yuexiu Real Estate Investment Trust (“Yuexiu REIT”) wishes to offer you the choice to receive Corporate Communications (as defined below) either: (i) in printed English language version only; (ii) in printed Chinese language version only; (iii) in both the printed English and Chinese language versions; or (iv) by electronic means through Yuexiu REIT’s website.

“Corporate Communication(s)” include(s) any document(s) to be issued by Yuexiu REIT for the information or action of unitholders, including but not limited to:

- (a) the annual report\*;
- (b) the interim report\*;
- (c) a notice of meeting;
- (d) an offering document\*;
- (e) a circular; and
- (f) a proxy form.

(Save for the documents marked with an asterisk (\*) above, the Corporate Communications will be produced in both the English and Chinese languages and the unitholders will accordingly receive a printed version in both language versions regardless of their choice.)

**ACTIONS TO BE TAKEN**

We invite you to select your preferred language and means of receipt of Corporate Communications by ticking the appropriate box in the enclosed Reply Form and signing and returning the form to the unit registrar of Yuexiu REIT (the “Unit Registrar”), Tricor Investor Services Limited on or before **30 September 2018** (the “Relevant Date”), using the mailing label at the bottom of the Reply Form. You do not need to affix a stamp when returning if posted in Hong Kong otherwise, please affix an appropriate stamp.

If we do not receive the duly completed and signed Reply Form on or before the Relevant Date, we will, until and unless you inform us by reasonable notice in writing of your desire to receive future Corporate Communications in the other language or both languages, send you a printed Chinese language version of each future Corporate Communication if, according to the register of unitholders, you are a natural person with a Chinese name and have an address in Hong Kong; otherwise, we will send you a printed English language version.

**POINTS TO NOTE**

- (1) Even after you have made your selection of your preferred language and means of receipt of Corporate Communications, you are entitled to change your selection at any time by reasonable notice in writing to the Unit Registrar, Tricor Investor Services Limited, Level 22, Hopewell Centre, 183 Queen’s Road East, Hong Kong.
- (2) Both the printed English and Chinese language versions of Corporate Communications will always be available from the date of despatch from Yuexiu REIT or the Unit Registrar on request, or on Yuexiu REIT’s website at [www.yuexiureit.com](http://www.yuexiureit.com) and Hong Kong Exchanges and Clearing Limited (“HKEX”) website at [www.hkex.com.hk](http://www.hkex.com.hk).
- (3) If you choose to receive Corporate Communications by electronic means, and for any reason have difficulty in gaining access to the Corporate Communications, you will promptly upon request be sent the Corporate Communications in printed form free of charge.
