Pursuant to the circular dated 23 February 2012, the capital reorganization which involves the following is effective from 20 March 2012:

- (i) share consolidation on the basis that every 10 issued and unissued shares of HK\$0.025 each consolidates into 1 consolidated share of HK\$0.25 each;
- (ii) capital reduction which reduces the par value of consolidated share of HK\$0.25 each to HK\$0.01 each; and
- (iii) increase in authorized share capital which increases the authorized share capital from HK\$16,000,000 (divided into 1,600,000,000 new shares) to HK\$400,000,000 (divided in to 40,000,000,000 new shares).
