**VOLUNTARY ANNOUNCEMENT INTERIM INJUNCTION  
AGAINST ON DEBTOR CHINA CARBON NEUTRAL DEVELOPMENT  
GROUP LIMITED TO FREEZE ITS ASSETS**

This announcement is made by Zhong Ji Longevity Science Group Limited (the “**Company**”) together with its subsidiaries, the “**Group**”) on a voluntary basis. (Pursuant to the Company announcement of 27 May 2022 and 1 June 2022 and 9 June 2022 on Debts Recovery exercise on debtor China Carbon Neutral development Group Limited (“**China Carbon**”), which is a company listed in Hong Kong with stock code 1372, for HK\$43,140,328.77 of principal and incurred interest, as at 28 February 2022. Herein is the latest legal proceeding adopted by the Company against debtors China Carbon).

Hereby announces that creditor Joy Wealth Finance Limited 寶欣財務有限公司 (“**Joy Wealth**”) instructs Boase Cohen & Collins to have meeting with counsel regarding the interim injunction against debtor China Carbon to freeze its assets.

As advised by counsel, the High Court has jurisdiction to grant interim injunction against debtor China Carbon to freeze its assets such as landed properties and monies in banks pending the outcome of the civil litigation. Boase Cohen & Collins are now preparing the work of interim injunction for creditor Joy Wealth against debtor China Carbon.

The Company will keep the shareholders and potential investors informed of the latest progress of the China Carbon debts recovery or any other exiting loan portfolio major recovery, will make further announcement as and when appropriate in accordance with the Listing Rules.
