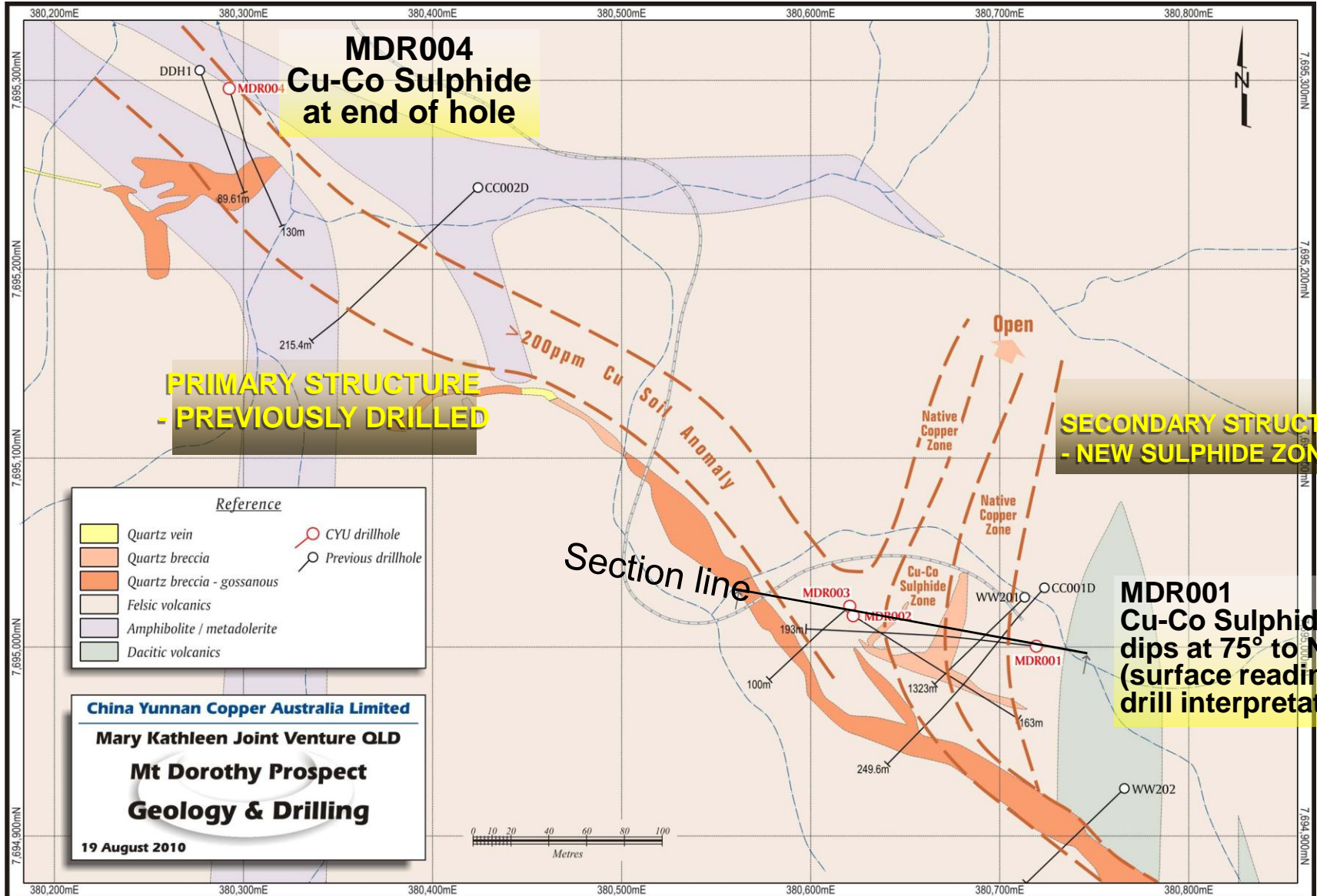

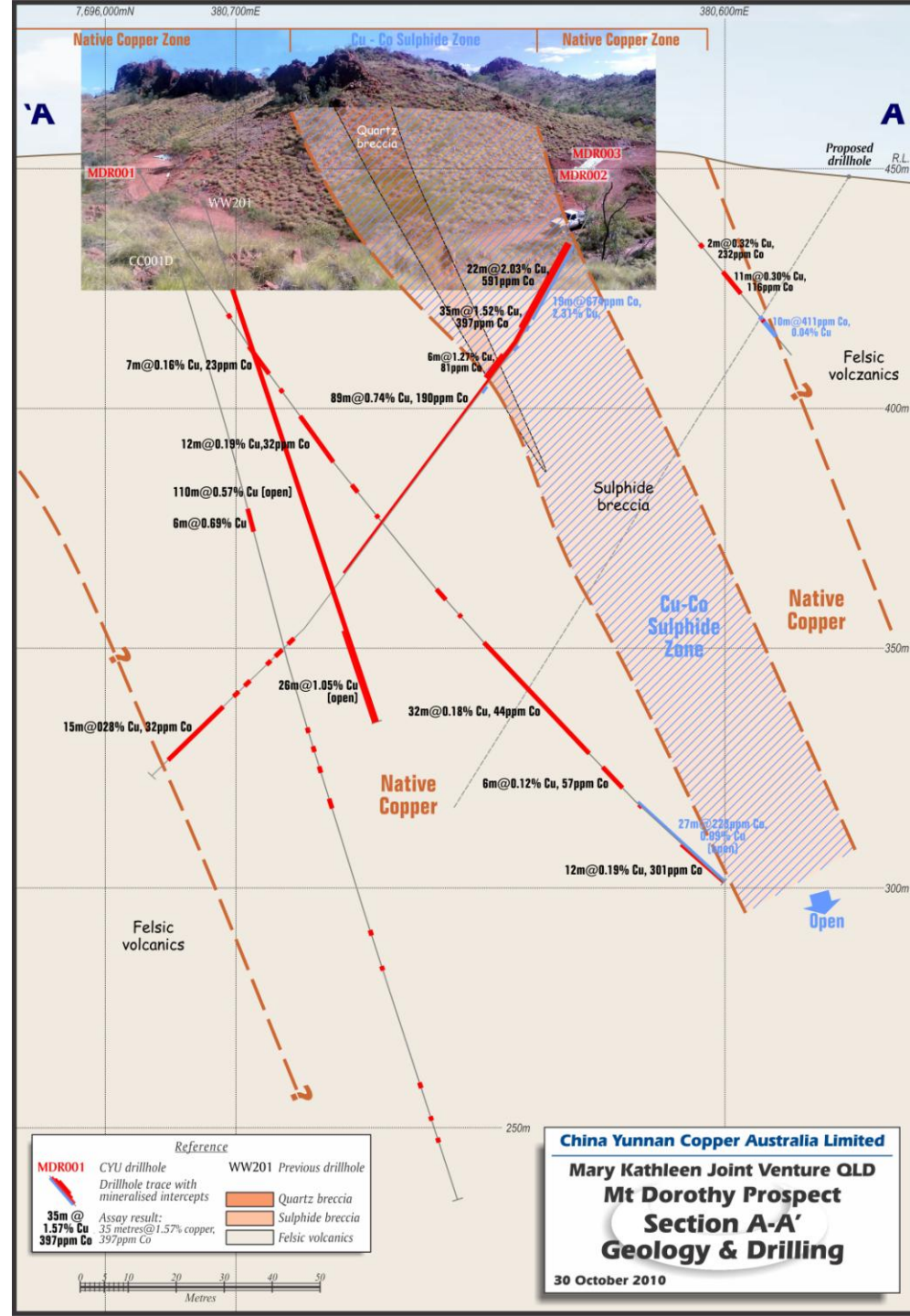

# Mt Dorothy Section

## Target Dimensions

- Ernest Henry style breccia mineralisation
- Mt Dorothy drill results: 35m @ 1.52% Copper & 397ppm Cobalt
- Chacopyrite & chalcocite sulphide breccia surrounded by lower grade native copper 'envelope'
- Phase 2 – Depth & along-strike drilling in November to build dimension
- Cobalt credits
- Possible metallurgical test work after Phase 2 drilling.





# Mt Dorothy Drillhole MDR002

- Shallow sulphide mineralisation in RC drill chips
- 20m-25m interval returned assays of:  
5m @ 3.15% copper, 1473ppm cobalt

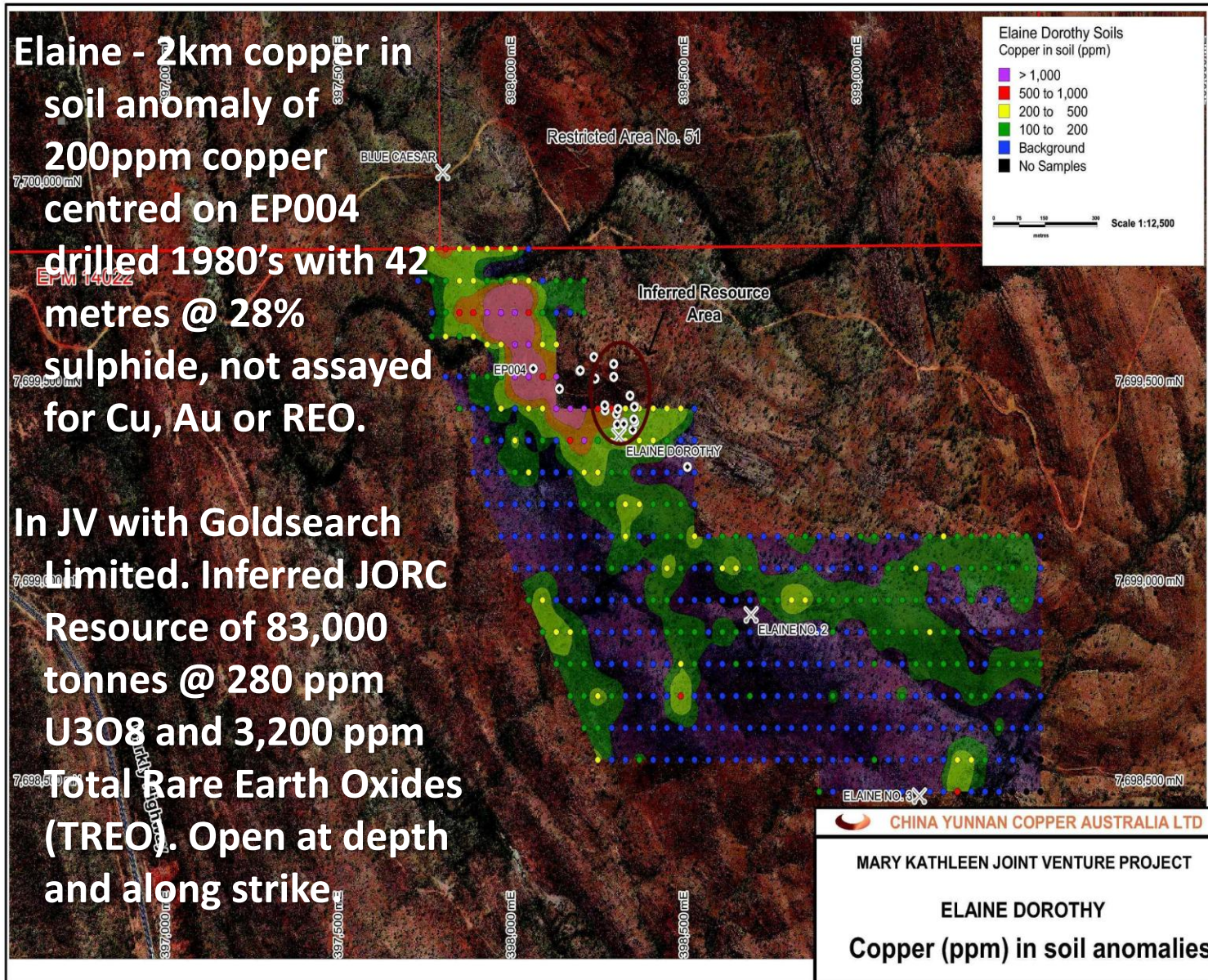




# Elaine – Copper and Rare Earth Elements

Elaine - 2km copper in soil anomaly of 200ppm copper centred on EP004 drilled 1980's with 42 metres @ 28% sulphide, not assayed for Cu, Au or REO.

In JV with Goldsearch Limited. Inferred JORC Resource of 83,000 tonnes @ 280 ppm U3O8 and 3,200 ppm Total Rare Earth Oxides (TREO). Open at depth and along strike

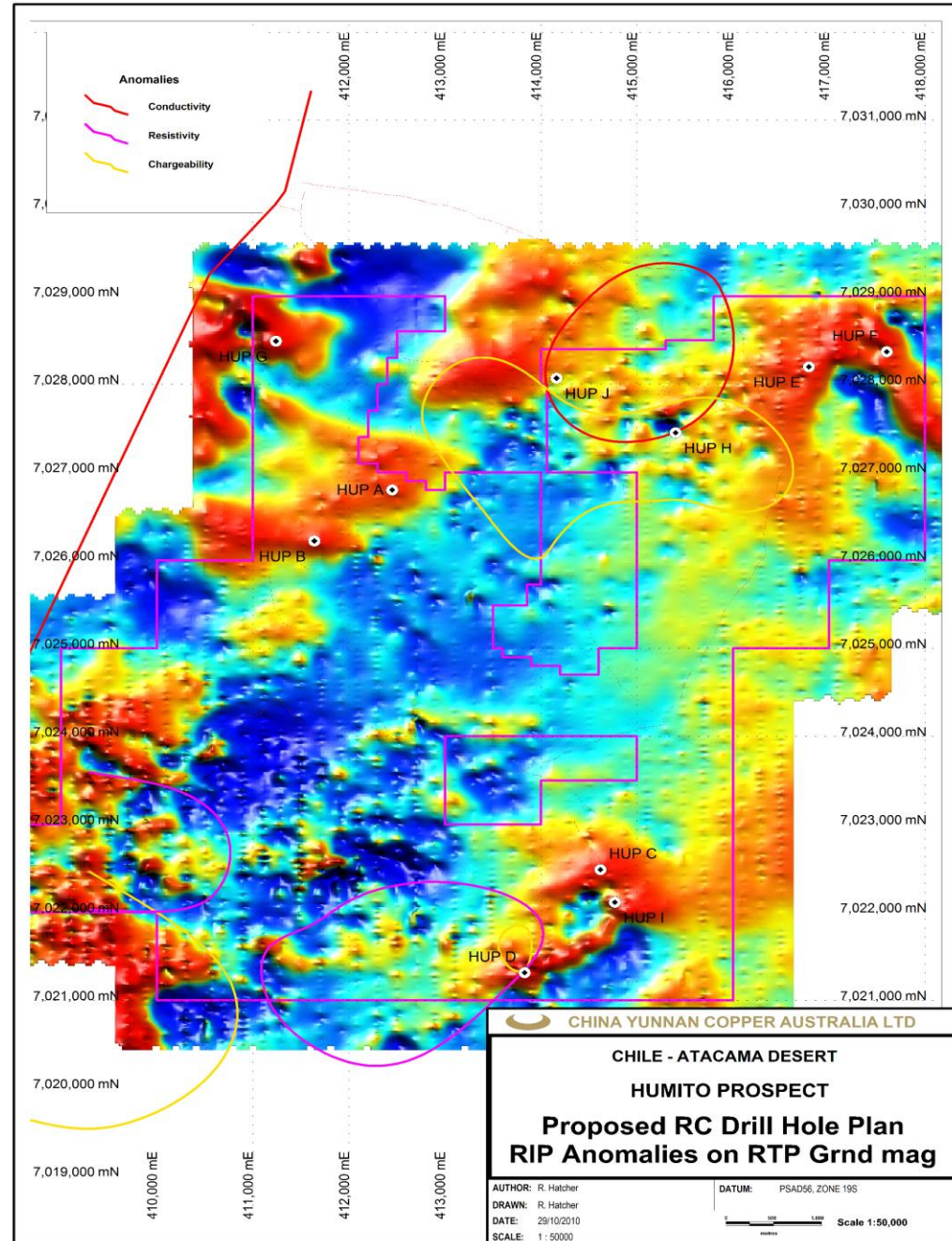
# Chile – Drill Targets

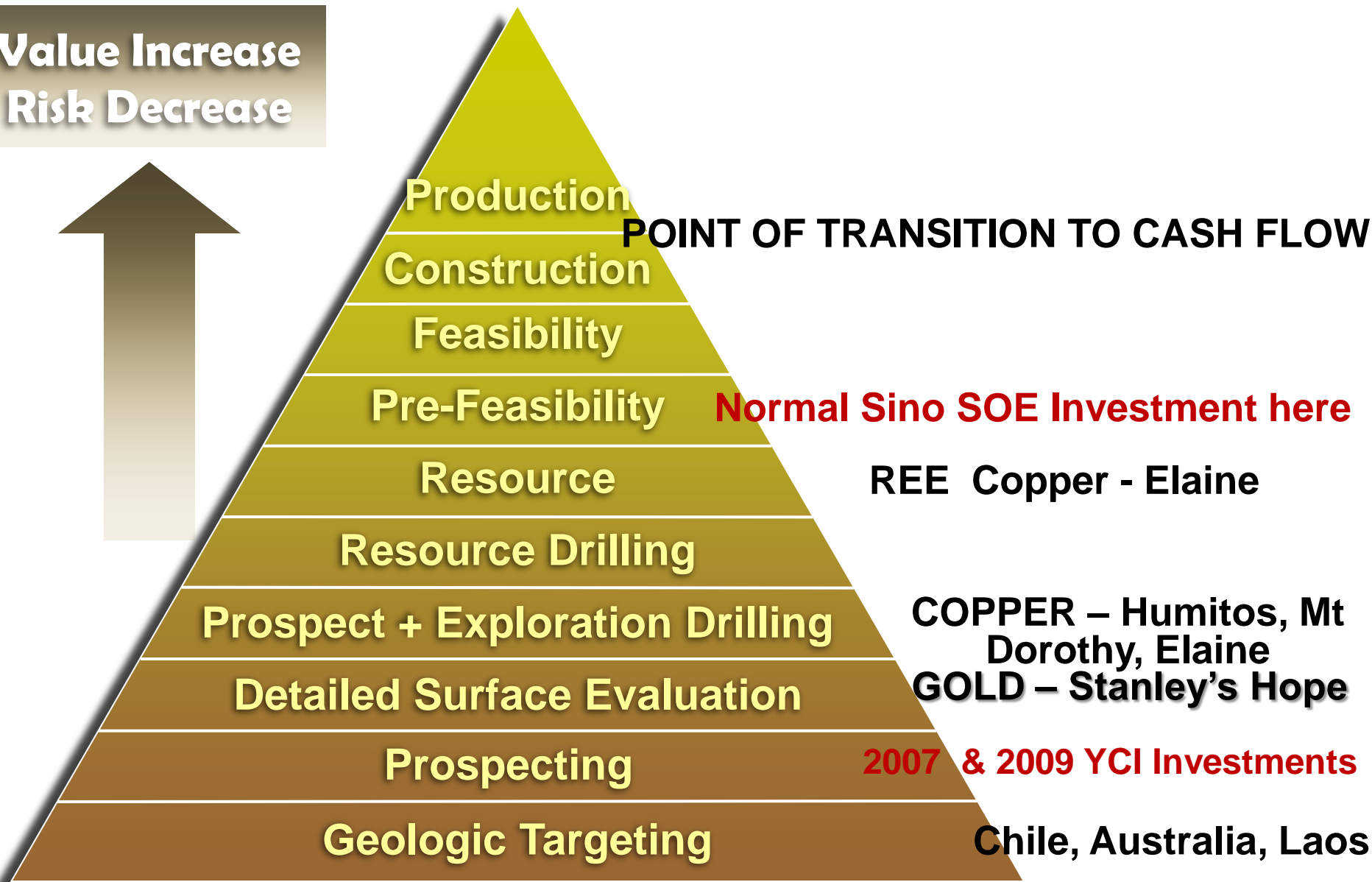
