#### Appendix 4C Quarterly Cash Flow report to 31 December 2009

**29 January 2010 – Sydney, Australia, Auckland, New Zealand– Living Cell Technologies Limited (ASX: LCT; OTCQX: LVCLY)** today announced the quarterly cash flow report for the quarter ended 31 December 2009. The Appendix 4C is attached.

The cash balance at the end of the quarter was \$5,494,840 compared to \$5,021,780 at 30 September 2009. This improvement reflects the Share Purchase Plan which closed on 17 December raising \$2.2 million.

Net operating cash outflows were \$1,676,991 compared to \$1,661,828 last quarter. Expenditure included \$677,827 on research and development (\$734,753 last quarter) to meet the supply of DIABECELL<sup>®</sup> for the clinical trials in New Zealand and Russia. Cash received from Government grants was \$0 (\$0 last quarter). Receipts from customers were \$163 (\$146 last quarter).

Capital expenditure was \$25,221 in the quarter, compared to \$118,541 last quarter, which included commissioning of the new high health pig facility in Southland.

During the quarter two patients were implanted with a medium dose in the New Zealand the clinical trial of DIABECELL<sup>®</sup>, the company's encapsulated insulin producing cells for type 1 diabetes. The first patient was reported to have dropped his daily insulin dose by 30% while maintaining his usual blood glucose levels. The Phase I/IIa clinical trial in Russia has continued to show positive results with low and medium doses of DIABECELL<sup>®</sup>. To date, eight patients with insulin dependent diabetes have received between one and three implants of DIABECELL<sup>®</sup> without remarkable adverse events.

In December the company signed a further research collaboration with Centocor Research & Development Inc. and granted an exclusive two year option to take up a world-wide licence for LCT's encapsulation technology for use in a specified field. The research fees and annual option fees will provide a revenue stream for the company.

Living Cell Technologies (LCT) is developing cell-based products to treat life threatening human diseases. The Company owns a biocertified pig herd that it uses as a source of cells for treating diabetes and neurological disorders. For patients with type 1 diabetes, the Company transplants microencapsulated islet cells so that near-normal blood glucose levels may be achieved without the need for administration of insulin or at significantly reduced levels. The company entered clinical trials for its diabetes product in 2007. For Parkinson's disease, Huntington's disease and other neurological disorders, the company is developing microencapsulated choroid plexus cells that deliver beneficial proteins and neurotrophic factors to the brain. LCT's technology enables healthy living cells to be injected into patients to replace or repair damaged tissue without requiring the use of immunosuppressive drugs to prevent rejection. LCT also offers medical-grade porcine-derived products for the repair and replacement of damaged tissues, as well as for research and other purposes.
