Appendix 4C Quarterly Cash Flow Report 31 December 2019

Sydney, Australia & Auckland, New Zealand, 30 January 2020 – Living Cell Technologies Limited today released its cash flow report for the quarter ended 31 December 2019. The Appendix 4C is attached. The company ended the quarter with a cash balance of \$3,477,874 compared to \$3,342,174 in the previous quarter. The cash position was boosted by the sale of 121,995 shares in Semma Therapeutics, which realised \$1,100,159 when Vertex Pharmaceuticals Incorporated completed its acquisition of Semma Therapeutics during the quarter.

Net operating cash flow in the quarter was \$(967,063) compared to \$(1,492,377) in the previous quarter. Receipts from grants and tax incentives were \$107,279 (previous quarter \$284,468).

Operating payments were \$1,108,143 compared to \$1,862,272 in the previous quarter.
