LCT exits peptide projects

Sydney, Australia & Auckland, New Zealand, 29 March 2021 – Living Cell Technologies Limited's (LCT) research and related licence contracts with the University of Auckland will terminate with effect from 25 March 2021. LCT will pay the University net NZD 400,000 on account of work done, and expects to recover part of this amount from third parties.

The contracts were to develop early preclinical candidates of lipidated calcitonin gene-related peptide and lipidated pramlintide peptide compounds for possible treatment of migraine and obesity respectively.

LCT will terminate these projects at the end of the contracts, as the projects did not reach the desired endpoints.

The company continues to look for research project opportunities to maximise its financial assets.
