- Please insert the name and address of the proxy desired. If no name is inserted, the chairman of the AGM will act as your proxy. Any alteration made to this
 proxy form must be initialled by the person who signs it.
- 4. Important: if you wish to vote for any resolution, tick in the box marked "For". If you wish to vote against any resolution, tick in the box marked "Against". Failure to tick either box will entitle your proxy to cast your vote at his discretion. Your proxy will also be entitled to vote at his discretion on any resolution properly put to the AGM other than that referred to in the notice convening the AGM. If you wish to vote part of your shares for and part of your shares against the resolution in the event that a poll is called, please insert the number of shares in the relevant box.
- 5. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation or institution, either under its common seal or under the hand of an officer or attorney duly authorised in that regard. Any alteration made to this form of proxy must be signed by the person who signs it
- 6. Where there are joint holders of any shares in the share capital of the Company, any one of such joint holders may vote, either in person or by proxy, at the AGM, but if more than one of such joint holders are present at the AGM, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- 7. To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointor pursuant to a power of attorney or other authority, a certified copy of that power of attorney or other authority, must be delivered, to the office of the Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited at Rooms 1712–16, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than 48 hours before the time appointed for holding the AGM.
- 8. The proxy need not be a member of the Company but must attend the AGM in person to represent you.
- 9. A shareholder or his/her/its proxy should produce proof of identity when attending the AGM. If a corporate shareholder appoints its legal representatives to attend the meeting, such legal representative shall produce proof of identity and a copy of the resolution of the board of directors or other governing body of such shareholder appointing such legal representative to attend the AGM.
- 10. Completion and deposit of this form of proxy will not preclude you from attending and voting in person at the AGM, if you so wish. In such event, the form of proxy will be deemed to have been revoked.
- 11. On a poll, every member who is present in person or by proxy or (being a corporation) is present by a duly authorised representative shall have one vote for every fully paid up shares of which he is the holder.
- 12. The full wording of the resolutions proposed at the AGM is set out in the Circular of the Company dated 29 April 2009.
