FURTHER DELAY IN DISPATCH OF CIRCULAR REGARDING NON-EXEMPT CONTINUING CONNECTED TRANSACTION – SERVICES AGREEMENT

We refer to the announcement of Alibaba Health Information Technology Limited (the “**Company**”) dated April 1, 2016 in relation to, among other things, the non-exempt continuing connected transactions contemplated under the services agreement (the “**Services Agreement**”) entered into between Alibaba Health Technology (Beijing) Company Limited, a wholly owned subsidiary of the Company, and the Tmall Entities on April 1, 2016, and the announcements of the Company dated April 25 and May 25, 2016, respectively, in relation to the delay in dispatch of the Circular (collectively, the “**Announcements**”). Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Announcements.

As disclosed in the Announcement dated May 25, 2016, the date of despatch of the Circular has been postponed to a date on or around June 24, 2016. However, the Company requires more time as originally envisaged to finalize the Circular, including but not limited to the letter from the Independent Financial Adviser. The Company currently expects that the despatch date of the Circular will be further delayed to a date on or around July 12, 2016.
