At the Annual General Meeting of Allied Group Limited (the “Company”) held on 25th May, 2018 (the “AGM”), a poll was demanded by the Chairman of the Meeting for voting on all the proposed resolutions as set out in the notice of the AGM dated 23rd April, 2018 (the “Notice”). As at the date of the AGM, the total number of issued shares of the Company (the “Shares”) was 175,754,118 Shares, which was the total number of Shares entitling the holders to attend and vote on the resolutions at the AGM. Therefore, the Company is allowed to issue a maximum of 35,150,823 Shares under the Securities Issue Mandate and to repurchase a maximum of 17,575,411 Shares under the Shares Repurchase Mandate. There were no Shares entitling the holders to attend and abstain from voting in favour of the proposed resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and no shareholders of the Company or their associates were required under the Listing Rules to abstain from voting on the proposed resolutions at the AGM. There was no restriction on any shareholders of the Company to cast votes on any of the proposed resolutions at the AGM and there was no party who had stated his/her/its intention in the circular to the shareholders of the Company dated 23rd April, 2018 to vote against or to abstain from voting on the proposed resolutions at the AGM.

The Company’s share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.
