- Where there are joint holders of any shares of the Company, any one of such joint holders may vote at the Meeting either personally or by proxy in 7. respect of such share as if he/she was solely entitled thereto, but if more than one of such joint holders are present at the Meeting personally or by proxy, that one of such joint holders so present whose name stands first on the register of members of the Company shall alone be entitled to vote in respect of such shares.
