INSIDE INFORMATION UPDATE ON LITIGATION INVOLVING A SUBSIDIARY

This announcement is made by Alltronics Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 14 September 2021, 12 October 2021, 20 January 2022, 21 February 2022, 25 February 2022 and 6 April 2022 (the “**Announcements**”) in relation to a litigation involving a subsidiary. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meaning as those defined in the Announcements.

Shenzhen Allcomm was informed by the legal adviser handling the Litigation that the second hearing of the Litigation has taken place on 29 April 2022 and the legal adviser has attended the second hearing on behalf of Shenzhen Allcomm. As at the date of this announcement, the Court is still verifying the information and documents submitted by both parties and has not rendered any judgement on the Litigation.

The Company believes that the Litigation and the Court Order will not have any material adverse effect on the Group and the business and operations of the Group remain normal. The Company will keep the shareholders and potential investors of the Company informed of any further material development by way of announcement as and when appropriate.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the securities of the Company.
