INSIDE INFORMATION UPDATE ON LITIGATION INVOLVING A SUBSIDIARY

This announcement is made by Alltronics Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 14 September 2021, 12 October 2021, 20 January 2022, 21 February 2022, 25 February 2022, 6 April 2022, 3 May 2022, 13 September 2022 and 26 September 2022 (the “**Announcements**”) in relation to a litigation involving a subsidiary. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meaning as those defined in the Announcements.

Shenzhen Allcomm was informed by the legal adviser handling the Litigation that the Dongguan Intermediate People’s Court* (東莞市中級人民法院) (the “**Intermediate Court**”) has issued a civil judgement dated 16 March 2023 (the “**Appeal Judgement**”) in relation to the civil appeal (the “**Appeal**”) against the rulings in the first instance trial of the Litigation. In the Appeal Judgement, the Intermediate Court has revoked the rulings in the first instance trial and the case was remanded to the Dongguan No. 3 People's Court* (東莞市第三人民法院) for a retrial (the “**Retrial**”).

As at the date of this announcement, the hearing date of the Retrial has not been scheduled. Shenzhen Allcomm will vigorously defend the Plaintiff’s claims in the Retrial.

The Company believes that the Retrial will not have any material adverse effect on the Group and the business and operations of the Group will remain normal. The Company will keep the shareholders and potential investors of the Company informed of any further material development by way of announcement as and when appropriate.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the securities of the Company.
