SUMMARY

Net Proceeds from Global Offering

- Based on the Offer Price of HK\$1.20 per Share, the net proceeds of the Global Offering to be received by the Company (after deducting underwriting commission and other expenses payable by the Company in connection with the Listing) is estimated to be approximately HK\$335.7 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net Proceeds” below in this announcement.

Applications under the Hong Kong Public Offer

- The Offer Shares initially offered under the Hong Kong Public Offer have been slightly over-subscribed. A total of 8,272 valid applications have been received under the Hong Kong Public Offer for a total of 265,496,000 Hong Kong Offer Shares, representing approximately 7.59 times of the 35,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offer.
- As the Hong Kong Public Offer is oversubscribed but the oversubscription is less than 15 times, the discretionary reallocation procedures as described in the paragraph headed “Structure of the Global Offering — The Hong Kong Public Offer — Reallocation and Clawback” in the Prospectus has been applied and a total of 35,000,000 Offer Shares have been reallocated to the Hong Kong Public Offer. The final number of the Offer Shares allocated to the Hong Kong Public Offer is 70,000,000 Offer Shares, representing 20% of the total number of Offer Shares initially available under Global Offering. The Sole Sponsor and each of the Directors confirm that the Allocation Cap (as defined below) has not been exceeded.

International Placing
