**(1) As a result of the Capital Reorganisation becoming effective after 4:00 p.m. on 5th August, 2009 (Hong Kong time), the parties to the S&P Agreement entered into a supplemental agreement on 19th August 2009 agreeing to change the Conversion Price under the FCL Convertible Note from HK\$0.11 per Conversion Share to HK\$ 1.10 per Conversion Price.**

**(2) Regarding the announcement dated 3<sup>rd</sup> April 2009 and the circular dated 24<sup>th</sup> April 2009, it was proposed the normal value of each issued share be reduced from HK\$0.10 to HK\$0.01 by cancelling HK\$0.09 and every ten reduced share of HK\$0.01 each be consolidated into one issued share of HK\$0.10. It is expected to be completed in September 2009 upon EGM approval and fulfilment certain conditions which stated in the circular.**
