1. Reference is made to the announcements of the Company dated 6 June 2017 and 15 June 2017 in relation to the issuance of the Convertible Bonds (the “Announcements”). Capitalised terms used in this monthly return shall have the same meanings as those defined in the Announcements unless otherwise stated. Convertible Bonds in the principal amount of US\$100,000,000 (equivalent to approximately HK\$780,000,000), carried interest at 4% per annum, and with maturity date of 13 June 2019 were issued by the Company to the Subscriber at the initial Conversion Price of HK\$0.425 per Conversion Share on 14 June 2017.

Assuming the exercise in full of the conversion rights attaching to the Convertible Bonds at the initial Conversion Price of HK\$0.425 per Conversion Share, a total of 1,835,294,118 Conversion Shares will be issued.
