Share consolidation (the "Share Consolidation") on the basis that every ten issued and unissued ordinary shares of HK\$0.001 each in the share capital of the Company were consolidated into one ordinary share of HK\$0.01 each (the "Consolidated Share") in the share capital of the Company with effect from 12 November 2018.
2. As a result of the Share Consolidation became effective on 12 November 2018,
 - (a) the outstanding share options will entitle holders to subscribe for up to 68,827,582 Consolidated Shares.
 - (b) the outstanding share options will entitle holders to subscribe for up to 126,681,513 Consolidated Shares.
 - (c) the conversion price became HK\$4.25 per convertible share and the outstanding convertible bonds will entitle holders to convert into 181,694,117 Consolidated Shares if fully converted.
 - (d) the conversion price became HK\$4.25 per convertible share and the outstanding convertible bonds will entitle holders to convert into 100,987,529 Consolidated Shares if fully converted.
 - (e) the conversion price became HK\$0.88 per convertible share and the outstanding convertible notes will entitle holders to convert into 211,190,249 Consolidated Shares if fully converted.
