ORDINARY RESOLUTIONS

- 1. To receive and adopt the audited consolidated financial statements of the Company and the reports of the directors (the "**Directors**") and auditor of the Company for the year ended 31 December 2022.
- 2. (a) To re-elect the following retiring Directors:
 - (i) Mr. GAO Nianshu as an executive Director;
 - (ii) Mr. YANG Lin as a non-executive Director;
 - (iii) Mr. CHENG Xike as a non-executive Director;
 - (iv) Dr. ZHANG Ya-Qin as an independent non-executive Director; and
 - (b) To authorise the board of Directors (the "Board") to fix the remuneration of the Directors.
