Remarks (if any): The Company does not have an authorised share capital and par value of shares in its share capital. The convertible notes ("CN") in the principal amount of HK\$140,000,000 were placed and issued to six individual noteholders on 17 November 2016 pursuant to the placing agreement dated 3 November 2016. Please refer to the Company's announcements dated 3 November 2016, 17 November 2016 and 31 December 2018 for details. The conversion period of the remaining CN in the principal amount of HK\$84,000,000 expired on 17 November 2018. † On 27 March 2020, the Company repaid HK\$23,520,000 (equivalent to 28% of the outstanding principal amount) to the remaining noteholders. On 20 April 2020, the Company received four statutory demands issued from the legal advisers to the remaining noteholders and the Company is dealing with this matter. Please refer to the Company's announcement dated 27 March 2020 and 21 April 2020 for details. Further announcement will be issued by the Company upon completion of the discussion with the noteholders.
