six individual noteholders on 17 November 2016 pursuant to the placing agreement dated 3 November 2016.

The conversion period of the remaining CN in the principal amount of HK\$84,000,000 expired on 17 November 2018.

[†] On 27 March 2020, the Company repaid HK\$23,520,000 (equivalent to 28% of the outstanding principal amount)

to the remaining noteholders.

On 20 April 2020, the Company received four statutory demands issued from the legal advisers to the remaining

noteholders and the Company is dealing with this matter.

On 10 December 2020, the Company repaid CNY30,000,000 (equivalent to HKD35,433,000) to the remaining

noteholders.
