As at the date of the AGM, the total issued share capital of the Company comprised of 586,210,053 shares, which was the total number of shares entitling the holders to attend the AGM and vote on all the resolutions put forward at the AGM (the "AGM Resolutions"). Shareholders holding an aggregate of 374,900,770 voting shares, representing approximately 63.95% of the total issued shares of the Company, attended the AGM either in person or by proxy. No shareholder was required to abstain from voting on the AGM Resolutions. There was no share entitling the holder to attend the meeting and vote only against the AGM Resolutions.
