The board of directors of the Company considers that the contents of the relevant article published by Next Magazine on 14 July 2010 are defamatory to the Group and/or amount to malicious falsehood. Therefore, the Company commenced legal proceedings (the "Legal Proceedings") in the High Court of Hong Kong in October 2010 against Next Magazine seeking, *inter alia*, damages and an injunction to restrain Next Magazine from publishing contents or similar contents. The trial of the Legal Proceedings lasted for a total of 40 days and has ended on 29 August 2015.

As disclosed in the Announcement and the Annual Report, the judge of the High Court estimated that the judgment could be ready for handing down before 30 April 2016. The Company was informed by the judge of the High Court today that the latest estimated date for handing down judgment is on or before 31 May 2016. The Company will make further announcements to update the shareholders and the potential investors of the Company as and where appropriate in compliance with the Listing Rules.
