**FURTHER DELAY IN DESPATCH OF CIRCULAR
RELATING TO VERY SUBSTANTIAL ACQUISITION:
PROPOSED CAPITAL INJECTION INTO JOINT VENTURE**

References are made to the announcement of Beijing Development (Hong Kong) Limited (the “**Company**”) dated 28 June 2012 (the “**Announcement**”) in relation to, among other things, the proposed injection of Capital Investment and Equity Premium and proposed advancement of the Shareholder’s Loans pursuant to the terms of the Increase of Capital Contract and the announcements of the Company dated 30 July 2012, 31 August 2012, 27 September 2012, 23 November 2012, 30 November 2012, 31 January 2013, 28 March 2013, 24 May 2013 and 28 June 2013 in relation to further delay in despatch of Circular (as defined below). Unless otherwise defined, terms used herein shall have the same meanings as those defined in the Announcement.

As disclosed in the announcement of the Company dated 28 June 2013, a circular (the “**Circular**”) containing, among other things, (i) further details on the Transaction; (ii) financial information of the Group; (iii) financial information of the Joint Venture; and (iv) unaudited pro forma financial information of the Enlarged Group is expected to be despatched to the Shareholders on or before 30 September 2013. However, as additional time is required for the Company to finalise the information to be contained in the Circular, the board of directors of the Company (the “**Board**”) expects the date of despatch of the Circular to the Shareholders will be delayed to a date falling on or before 31 December 2013.
