**DELAY IN DESPATCH OF CIRCULAR  
RELATING TO VERY SUBSTANTIAL ACQUISITION:  
PROPOSED CAPITAL INJECTION INTO JOINT VENTURE**

Reference is made to the announcement of Beijing Development (Hong Kong) Limited (the “**Company**”) dated 28 June 2012 (the “**Announcement**”) in relation to, among other things, the proposed injection of Capital Investment and Equity Premium and proposed advancement of the Shareholder’s Loans pursuant to the terms of the Increase of Capital Contract. Unless otherwise defined, terms used herein shall have the same meanings as those defined in the Announcement.
