Please mark " \checkmark " in the appropriate box in the enclosed Reply Form and sign and return the same by hand or by post (no stamp needs to be affixed if posted in Hong Kong by using the mailing label at the bottom of the Reply Form) to the Company's share registrar, Tricor Tengis Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, or by sending an email for the purpose to 392-ecom@vistra.com.

If we do not receive the completed and signed Reply Form from you on or before 31 May 2024 and until you inform the Company's share registrar by reasonable notice in writing, you will be deemed to have consented to receiving all future Corporate Communications from the Company in the manner as set out in option (1) above, and a notification of the publication of the Corporate Communications on the Company's website will be sent to you by email (if no email address is provided, by post to your registered address).
