







2014年上半年全球經濟形勢更加複雜,歐美等發達經濟體對世界經濟增長的推動作用逐步增強,而新興經濟體經濟增速正在持續放緩。

中國經濟增長穩中趨緩,在合理增長區間內運行,但也面臨諸多結構性矛盾和風險隱患。北京控股及所屬企業積極應對國內外形勢變化,全力推進各項重點工作,實現公司經營業績的平穩增長。

The global economy in the first half of 2014 became more and more complicated as the developed economies of Europe, USA & other regions gradually escalated their efforts on promoting global economic growth. On the other hand, emerging economies continued to slow down.

The PRC economy grew steadily in a slow pace and within a reasonable range. However, it also faced various structural dilemma and hidden risks. BEHL and its subsidiaries actively responded to domestic & foreign changes and advanced vigorously in every different key project, thereby achieved a stable growth in its operating results.





北京燃氣 ----上半年天然氣銷售量約47億立方米,與去年持平,由於北京暖冬及沒有延長取暖季節影響,銷售量曾經下降3億立方米,到今年六月份已經追回來。完成營業收入143.4億港元,同比增長14.6%。儘管售氣量持平,通過努力挖潛增效,分銷氣利潤同比增長10%。含管輸業務收益,實現北控應佔溢利19.2億港元,同比增幅為5.9%。


Beijing Gas ---- gas sales volume for the first half year was approximately 4.7 billion cubic meters, flat compared with the same period a year earlier. Due to warm winter in Beijing, sales volume once dropped by 300 million cubic meter, but such drop was recovered in June. Revenue grew by 14.6% to HK\$14.34 billion. Although sales volume was unchanged, profit from gas distribution increased by 10% compared with the same period a year earlier. Profit attributable to BEHL (including profit from gas transmission) grew by 5.9% to HK\$1.92 billion.










銷售量分析 An analysis of sales volume by user sector



China Gas ---- BEHL completed its acquisition of 21.13% equity interests in China Gas from its holding company and issued 98,100,000 new shares as consideration by the end of 2013. Since 1 January 2014, the Group has commenced to consolidate the relevant profit attributable to its equity interests in China Gas. In the first half year, the Group's share of profit of China Gas was HK\$273 million, which was based on the profit attributable to shareholders of China Gas for the six months ended 31 March 2014.













(一) 積極推動天然氣清潔能源發展

Promote natural gas clean energy




- 以落實北京市政府「清潔空氣行動計劃」為重點,加快推進燃煤鍋爐清潔能源改造任務。 By focusing on the implementation of Beijing municipal government's "Action Plan for Clean Air", Beijing Gas accelerated its pace to carry out reconstruction works for coal-fired boiler clean energy.
- 截至六月,已完成149座燃煤鍋爐房共4,766蒸噸使用者單位的報裝工作。期內,積極推進重大項目實施,陝京四線配套門站及落地建設方案均已落實,西北及東北熱電中心配套燃氣管線設施建設已全部完成並實現通氣。

As at June, 149 coal-fired boiler rooms covering total user units of 4,766 t/h steams were completed. Beijing Gas actively implemented major projects during the period and had finalized the ancillary station and ground construction proposal for No. 4 Shaanxi-Beijing Pipeline. The construction of Northwest and Northeast Thermal Power Centres, together with their ancillary gas pipelines and facilities, had been completed and put into operation.

As a starting point, it further expanded the co-operation in the domestic and foreign natural gas sector industry chain and energy services.



Accelerated industrial chain expansion, and promoted actively the development of cooling-heating-power supply for the distributed natural gas energy along with the full facilitation of the development of vehicle gas market.

- 2013年底建成的加氣站,目前已運營25座。
 For the gas stations that were built by the end of 2013, 25 of them are currently in operation.
- 推動車輛市場全方位拓展,深度開發郊區縣車輛市場,截至目前已發展 1,529 輛天然氣汽車(市公交640輛,駕校車668輛,改裝車200輛,其他車輛21輛)。 Comprehensive development of the vehicle market was promoted and the development of the vehicle market in suburban regions and counties was intensified. Up to date, it had already developed 1,529 natural gas vehicles (including 640 urban public buses, 668 driving school vehicles, 200 converted vehicles and 21 other vehicles).







燕京啤酒 Yanjing Beer

In April this year, Beijing Development Environmental Protection (Haidian) Limited (a wholly-owned subsidiary of Beijing Development) entered into a "PPP Project In-principal Licensed Operation Agreement For The Recycling Energy Power Generation Plant In The Recyclable Economy Industrial Park of Haidian District, Beijing" with Commission of City Administration and Environment, Haidian District, Beijing Municipality to determine the mode of co-operation, its major conditions and principles.

 同日在香港聯交所發出通告,宣佈以5.2億港元代價,完成收購湖南及山東兩個已運營的垃圾 焚燒發電項目,日處理垃圾量合計將達到2,000噸(目前實際處理量1,550噸),標誌著北京 發展向儘快實現產業轉型、進軍環保固廢處理業務領域,邁出了堅實的一步。

On the same date, an announcement was released on Hong Kong Stock Exchange, announcing the completion of acquiring two waste incineration power generation projects that are already in operation in Hunan and Shandong at a consideration of HK\$520 million, and the total daily treatment volume will reach 2,000 tons (current actual treatment volume is 1,550 tons). The above signified that Beijing Development had marched forward a solid step towards achieving its industrial transformation and entered into the environmental protection and solid waste treatment business sector.

BE Water made full use of its local existing resources to co-operate actively with BE Environment to carry out the preparation works. For the ancillary sewage treatment plant project of the waste incineration project in Harbin, Heilongjiang, BE Environment and BE Water conducted synergistic collaboration in project construction. After obtaining the project's licensed operating right, the sewage treatment project of BE Environment will be taken up by BE Water for construction and operation. At the same time, BE Water committed the assurance of supplying of recycled water that are needed for the waste incineration plant in Harbin

北控於2013年底完成收購中國燃氣21.13%股權,並於2014年1月1日開始合併應佔中國燃氣股權之相關利潤。計算過增發9,810萬股北控新股的攤薄影響後,這收購為北控上半年的每股盈利增厚港幣5仙或2.5%。收購完成後,中國燃氣不斷交出理想的業績,現時中國燃氣股價比收購價高出一倍,實現了北控在股東通承指出收購中國燃氣對北控盈利的正面影響。

BEHL completed its acquisition of 21.13% equity interests in China Gas by the end of 2013 and since 1 January 2014 has started to consolidate the relevant profit attributable to its equity interests in China Gas. After off-setting the dilutive effect of the issue of 98,100,000 new BEHL consideration share, the acquisition still has brought an increase in the earning per share of BEHL for the first half of 2014 by 5 HK cents or 2.5%. After the completion of the acquisition, China Gas has continued to deliver ideal results. The current share price of China Gas is double the acquisition price paid by BEHL. It has realized the benefits brought by the acquisition stated in the circular to BEHL's shareholders.

》 2014年下半年,全球經濟形勢依然複雜嚴峻。從國際看,歐洲經濟復蘇進程緩慢;美國經濟已走上復蘇道路,退出量化寬鬆政策的過程影響著全球金融市場和經濟。

In the second half of 2014, the global economic situation remained complicated and austere. From an international perspective, the progress of the European economic recovery was slow, the US economy is heading towards to its recovery, and the quantitative easing policy exit process had affected the global financial markets and economies.

》 從國內看,上半年中國經濟運行總體平穩,下半年面對經濟下行壓力,宏觀經濟政策將保持穩中求進的總基調。

Domestically, the PRC economy that moved forward steadily overall in the first half year will face the pressure of economic downturn in the second half year. The macroeconomic policy will maintain its overall direction of making progress while maintaining stability.

From an industry perspective, for the gas business, with a drop in consumer price index, the reform of natural gas price mechanism reform is expected to achieve a breakthrough. For beer business, full efforts will be devoted to respond to the adverse impact as a result of industry development slowdown as well as decreasing residents' consumption power. For water and solid waste treatment businesses that are in their golden period of development, however, market competition is still intense and much efforts and focus must be given.

Endeavor to ensure the completion of coal-to-gas conversion of boilers ancillary projects on time. It will also strive to achieve the target of no coal-fired boiler inside Beijing's Fifth Ring Road by the end of 2014 and no coal-fired boiler inside Beijing 's Sixth Ring Road by the end of 2015.

 - Top priority will be given to upward product structural adjustment, rationalize market price mechanism of various products, increase the sales efforts of mid-end products, and achieve the fast growth in sales volume of Yanjing "draught beer" and canned beer.

Major tasks to be carried out by Beijing Development will include the implementation of investment and operation of the Beijing Haidian District Cyclic Economy Industrial Park Renewable Energy Power Generation Project. The Project is a remarkable and large waste incineration power generation project under construction in Beijing with a daily waste treatment capacity of 2,500 tonnes. Beijing Development is now proactively negotiating with its counterparties to fix the relevant commercial terms with an aim to sign a formal licensed operation agreement and other supplemental agreements in the second half of 2014 to facilitate the trial operation of the Project at the beginning of next year.

結束語 Conclusion

下半年,北京控股及所屬企業將繼續及時捕捉市場機遇。香港跟上海即將實行滬港通,系內三隻股票,包括北京控股有限公司(392)、北控水務集團有限公司(371)以及中國燃氣控股有限公司(384)都被納入雙邊交易可買賣名單內。三隻股票都屬於市值較大,流通量活躍的股票,日後將會受到國內投資者追捧,對股價有正面影響,有利系內股票估值。

In the second half year, BEHL and its group companies will continue to seize market opportunities in a timely manner. Three of our group companies including BEHL (stock code: 392), BE Water (stock code: 371) and China Gas (stock code: 384) have been included in the forthcoming Shanghai-Hong Kong Stock Connect to achieve mutual market access. As the three stocks are all sizable in terms of market capitalization and trading volume, it is anticipated that the three stocks will embrace welcoming response and positive effect on stock price performance as well as valuation.
