(Hong Kong, 16 March 2018) Beijing Enterprises Holdings Limited (“Beijing Enterprises” or the “Company”, stock code: 392.HK), the comprehensive public utilities service provider engaging in gas, water, solid waste treatment and beer businesses, is pleased to announce that due to its commitment to caring for the community, caring for the employees and caring for the environment, it is awarded the 2017-2018 Caring Company Logo by The Hong Kong Council of Social Service (HKCSS).

Launched by the HKCSS in 2002, the Caring Company Scheme aims at cultivating good corporate citizenship. It is specifically geared to building strategic partnerships among businesses and non-profit organisations to create a more cohesive society. Beijing Enterprises is awarded the Caring Company Logo in recognition of its efforts and achievements in undertaking social responsibility, caring for the society, caring for the employees and protecting the environment.

As Beijing's first state-owned holdings company listed in Hong Kong, Beijing Enterprises has been committed to "Booming in Hong Kong with a foothold in Beijing", while paying attention to the harmonious development of its own businesses alongside the economy, society and environment. In the past year, it made proactive efforts in participating in social services so as to give back to the society for their supports and understandings.

On 22 October 2017, under the promotion of Beijing Enterprises, 45 staff from the Company and other corporations in Hong Kong under BE Group, including Beijing Holdings, Beijing Enterprises Water Group, Beijing Enterprises Clean Energy, Beijing Properties, Beijing Enterprises Environment and C Cheng Holdings, participated in a 12-km race in the 19th Sowers Challenging 12 Hours Charity Marathon, finishing the competition as the 1st runner-up and 2nd runner-up in the corporate group at the same time. This was the second time for Beijing Enterprises to participate in the event and it was awarded the Corporate Participation Gold Award. The funds raised in this charitable event will be fully used to support the education of the children from the backward mountain regions of China and to spread the social culture of caring and integration.

In addition, by taking the celebration of the 20th anniversary of the listing of Beijing Enterprises as an opportunity and using the care and enthusiasm of the staff of the Company as motivation, the "On The Way · BEHL" Charitable Walkathon Event was successfully held in 2017. In 20 cities at home and abroad where Beijing Enterprises has built presence, a 32-day relay of walkathon was completed with online and offline participation of 4,036 people, raising RMB4,036,000 in total. Beijing Enterprises supported the development of its charitable and environmental protection principles with actual participation by donating RMB 3,536,000 and RMB 500,000 to Hong Kong Mingxi Charity Foundation Association and SEE Foundation respectively.

Over the past 20 years, in respect of social services, Beijing Enterprises has identified and nurtured a lot of quality young talents for Hong Kong and the country by leading the establishment of Mingxi Charity Foundation Association and participating in the Fan Changjiang Action to encourage the learning and exchange among the students from Hong Kong and the mainland China. In the future, Beijing Enterprises will continue to make use of the charitable platform "On The Way·BEHL" so as to commence various charitable events, accomplish its social missions in a serious manner and proactively support the participation in social services.
