Remarks (if any):

The capital reorganisation of the Company (the “**Capital Reorganisation**”) became effective on 2 May 2019 (Hong Kong time) which involves, among others, the following :-

a) the share consolidation (the “**Share Consolidation**”) of every four (4) existing shares of HK\$0.04 each into one (1) consolidated share of HK\$0.16 each (each a “**Consolidated Share**”);

b) the reduction (the “**Capital Reduction**”) of the issued share capital of the Company through (i) elimination of any fraction of a Consolidated Share in the issued share capital of the Company arising from the Share Consolidation in order to round down the total number of Consolidated Shares to a whole number; and (ii) a cancellation of the paid-up capital of the Company to the extent of HK\$0.15 on each issued Consolidated Share so that the nominal value of each issued Consolidated Share be reduced from HK\$0.16 to HK\$0.01; and

c) the subdivision of each authorised but unissued Consolidated Share of HK\$0.16 each (which shall include the authorised but unissued share capital resulting from the Capital Reduction) into sixteen (16) new shares of HK\$0.01 each (each a “**New Share**”).

As a result of the Capital Reorganisation, the number of New Shares falling to be issued upon exercise of the outstanding share options was adjusted to 71,500,000 New Shares and the number of New Shares which fall to be issued upon full conversion of the outstanding convertible bonds was adjusted to 55,147,057 New Shares.

Details of the Capital Reorganisation are set out in the circular and announcement of the Company dated 16 January 2019 and 2 May 2019, respectively.
