The Company has a total of 505,700,000 outstanding Share Options, of which:

- 165,100,000 Share Options were granted on August 5, 2016 under the 2007 Scheme;
- 80,600,000 Share Options were granted on March 5, 2018 under the 2017 Scheme; and
- 260,000,000 Share Options were granted on October 26, 2018 under the 2017 Scheme.

1) Out of the 165,100,000 Share Options:

- 115,570,000 Share Options have been vested; and
- 49,530,000 Share Options shall be vested during the period commencing from August 5, 2019 and ending on August 4, 2020.

2) Out of the 80,600,000 Share Options:

- 34,520,000 Share Options shall be vested during the period commencing from March 5, 2019 and ending on March 4, 2020;
- 28,740,000 Share Options shall be vested during the period commencing from March 5, 2020 and ending on March 4, 2021; and
