The Company has a total of 473,490,000 outstanding Share Options, of which:

- 140,738,000 Share Options were granted on August 5, 2016 under the 2007 Scheme;
- 72,752,000 Share Options were granted on March 5, 2018 under the 2017 Scheme; and
- 260,000,000 Share Options were granted on October 26, 2018 under the 2017 Scheme.

1) Out of the 140,738,000 Share Options:

- 91,208,000 Share Options have been vested; and
- 49,530,000 Share Options shall be vested during the period commencing from August 5, 2019 and ending on August 4, 2020.

2) Out of the 72,752,000 Share Options:
