The board (the “Board”) of directors (the “Directors”) of **Bossini International Holdings Limited** (the “Company”, together with its subsidiaries, collectively the “Group”) hereby announces that on 1 June 2017 (the “Date of Grant”), the Company granted 620,000 share options (the “Share Options”) to an employee of the Group (the “Grantee”) to subscribe for an aggregate of 620,000 shares of HK\$0.10 each in the capital of the Company (the “Shares”) under the share option scheme adopted by the Company on 12 November 2013, subject to acceptance of the Grantee. Each Share Option shall entitle the holder of the Share Options to subscribe for one Share upon exercise of such Share Option at an exercise price of HK\$0.460 per Share, which represents the highest of (i) the closing price of HK\$0.455 per Share as stated in the daily quotation sheets issued by the Stock Exchange on 1 June 2017, being the Date of Grant; (ii) the average closing price of HK\$0.460 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant; and (iii) the nominal value of the Share.

By offering Share Options, the Company intends to provide management staff and key employees with additional performance incentives, and encourage them to remain in the employment of the Group and devote their best efforts to the Group, thereby advancing the interests of the Company and its shareholders.
