Election of Language and Means of Receipt of Corporate Communications

- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

For the purpose of environmental protection and cost saving, we recommend you to select the Website Version. If the Company does not receive the enclosed reply form or receive an objection from you by 6 November 2014 and until you inform the Company's Hong Kong Share Registrar by reasonable prior notice in writing or send such a notice to bossini@computershare.com.hk, you will be deemed to have consented to receiving the Website Version of the Corporate Communications and only a printed notification letter of the publication of the Corporate Communications on the Company's website will be sent to you in the future.

You have the right at any time by reasonable prior notice in writing to the Company's Hong Kong Share Registrar to change the choice of language and means of receipt of the Corporate Communications. You may also send such a notice by email to bossini@computershare.com.hk. Even if you have chosen (or are deemed to have consented) to receive the Website Version but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will upon your request send the Corporate Communications to you in printed form free of charge as soon as possible.
