At the annual general meeting (the "AGM") of Wah Nam International Holdings Limited (the "Company") held on 25th April, 2007 at 2:30 p.m. at Garden Room A & B, 2/F., Hotel Nikko Hong Kong, 72 Mody Road, Tsimshatsui East, Kowloon, Hong Kong, poll voting was demanded by the Chairman for voting on the proposed resolutions, as set out in the notice of AGM dated 23rd March, 2007. All resolutions were approved by shareholders of the Company and the board of directors (the "Board") of the Company is pleased to announce the poll results in respect of the resolutions of the AGM of the Company as follows:

Resolutions 1 to 4C were passed as ordinary resolutions. Shareholders may refer to the circular dated 26th March, 2007 issued to shareholders for details of some of the resolutions.

As at the date of the AGM, the issued share capital of the Company was 594,837,652 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions proposed at the AGM. There is no restriction on shareholders to cast vote on any of the aforesaid resolutions at the AGM.

Messrs. Deloitte Touche Tohmatsu, the auditor of the Company, have acted as the scrutineer and performed the procedures agreed with the Company including checking the mathematical accuracy of calculation of the poll results as counted by the Company, comparing the poll results of votes set out on poll forms collected by the Company and providing to the Company the factual findings. The work performed by Messrs. Deloitte Touche Tohmatsu in this respect did not constitute either an assurance engagement made in accordance with Hong Kong Standards on Auditing, Hong Kong Standards on Review Engagement or Hong Kong Standards on Assurance Engagements issued by the Hong Kong Institute of Certified Public Accountants nor did it include provision of any assurance or advice on matters of legal interpretation or entitlement to vote.

As at the date of this announcement, the Board comprises Mr. Cheng Yung Pun, Mr. Yu Sui Chuen and Ms. Cheng Wing See, Nathalie as executive directors, Mr. Luo ZhiJian as non-executive director and Mr. Au-Yeung Tsan Pong, Davie, Mr. Fung Ka Choi and Mr. Wong Chu Fung as independent non-executive directors.
