GRANTING OF GENERAL MANDATE TO ISSUE NEW SHARES AND TO REPURCHASE SHARES REFRESHMENT OF THE 10% GENERAL LIMIT ON GRANT OF OPTIONS UNDER THE SHARE OPTION SCHEME RE-ELECTION OF RETIRING DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

INTRODUCTION

The purpose of this circular is to provide you with information regarding certain resolutions to be proposed at the Annual General Meeting to enable you to make decisions on whether to vote for or against those resolutions.

At the Annual General Meeting, resolutions, amongst others, will be proposed for the Shareholders to approve (i) the grant of the General Mandate; (ii) the Repurchase Mandate; (iii) the Refreshment; and (iv) the re-election of the Directors.

GENERAL MANDATE TO ISSUE NEW SHARES

The Directors consider that it is in the best interests of the Company and its Shareholders to grant the General Mandate to the Directors to enhance the flexibility of any possible fund raising or acquisition. At the Annual General Meeting, an ordinary resolution will be proposed to approve the General Mandate for the Directors to allot, issue and otherwise deal with new Shares not exceeding in aggregate 20% of the nominal amount of the share capital of the Company in issue at the date of passing such resolution. As at the Latest Practicable Date, the number of shares in issue were 3,116,258,244. Assuming no further shares will be issued before the date of the Annual General Meeting, the Directors would be granted a General Mandate to issue up to 623,251,648 Shares.

The General Mandate, if granted will continue in force until (a) the conclusion of the next annual general meeting of the Company after the Annual General Meeting; or (b) it is revoked or varied by an ordinary resolution passed in a general meeting of the Company.

REPURCHASE MANDATE

At the Annual General Meeting, an ordinary resolution will therefore be proposed at the Annual General Meeting to approve the grant of the Repurchase Mandate to the Directors to repurchase Shares up to a maximum of 10% of the issued share capital of the Company as at the date of the Annual General Meeting.

REFRESHMENT OF THE 10% GENERAL LIMIT ON GRANT OF OPTIONS UNDER THE SHARE OPTION SCHEME

On 14 August 2002, the Company adopted the Share Option Scheme in compliance with the Listing Rules in respect of the share option schemes of a listed company.

As at 29 July 2009, there has been no option granted since the adoption of the Share Option Scheme.

As at 29 July 2009, the Company had refreshed the general limit of the Share Option Scheme, which allowed the Company to grant 273,025,824 share options.

From 29 July 2009 to the Latest Practicable Date, the Company has granted 36,000,000 share options of which none has been exercised, lapsed or cancelled, which represent approximately 1.2% of the total issued share capital of the Company.

The issued share capital of the Company has been increased since 29 July 2009. Assuming that no further Shares will be issued prior to the date of approving the refreshed general limit by the Shareholders, the maximum number of options that can be granted by the Company under the refreshed limit would be 311,625,824 Shares.

Mr. Luk Kin Peter Joseph, aged 39, has been the executive Director and Chairman of the Company since February 2009. He is also a director of certain subsidiaries of the Company. Mr. Luk holds a Master Degree in Business Administration and the professional qualification of Chartered Financial Analyst. Mr. Luk has worked in several international financial institutions and he is well-experienced in international financial and investment management.

Mr. Luk had been an executive director of China Mining Resources Group Limited, a company listed on the Stock Exchange, from 2 August 2005 to 5 July 2007.

Save as disclosed above, Mr. Luk did not have any directorship in other listed public companies in the past three years.

Mr. Luk has entered into a service contract with the Company but is not appointed for a specific term and will be subject to retirement by rotation and re-election at annual general meeting of the Company in accordance with the Bye-laws. Mr. Chan graduated from the University of British Columbia in Canada with a Bachelor of Commerce Degree and is a member of the American Institute of Certified Public Accountants. Mr. Chan has extensive experience in accounting and corporate finance. Mr. Chan is the executive director of China WindPower Group Limited and an independent non-executive director of Jackin International Holdings Limited and M Dream Inworld Limited. The above companies are listed on the Stock Exchange.

Save as disclosed above, Mr. Chan did not have any directorship in other listed public companies in the past three years.

As at the Latest Practicable Date, Mr. Chan has 1,500,000 share options of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Chan did not have any relationship with any Directors, senior management or substantial or controlling shareholders of the Company.

Mr. Chan did not enter into any services contract with the Company and is not appointed for a specific term but will be subject to the retirement by rotation and re-election at annual general meeting of the Company in accordance with the Bye-laws. Mr. Chan's remuneration is determined by reference to his duties and responsibilities with the Company and the prevailing market condition. Mr. Chan is entitle to receive an annual emolument of HK\$600,000.

Save as disclosed above, there is no other matter relating to the re-election of Mr. Chan that needs to be brought to the attention of the Shareholders, nor there is any other information that needs to be disclosed pursuant to the requirements of Rule 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Mr. Yip Kwok Cheung, Danny, aged 46, has been the independent non-executive Director of the Company since August 2009. Mr. Yip graduated from the Australian National University majoring in Economic and Accountancy. Mr. Yip has extensive experience as the Internet strategist, entrepreneur and specialist in international trade. He was also the founder of several service-oriented business in Hong Kong and Australia, and he was the founder of Tradeeasy Holdings Limited in 1996. He had been the executive director and chief executive officer of CCT Resources Holdings Limited (formerly known as Tradeeasy Holdings Limited) (a company listed on the growth enterprise market of the Stock Exchange) until June 2007.

REPURCHASE MANDATE

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide information to Shareholders regarding the Repurchase Mandate as referred to in the section headed "Repurchase Mandate" on page 4 of this circular.

SHARE CAPITAL

The shares proposed to be repurchased by a company must be fully paid-up. A maximum of 10% of the existing issued share capital as at the date of passing the relevant resolution may be repurchased on the Stock Exchange.

It is proposed that up to 10% of the Shares in issue at the date of passing the resolution to approve the Repurchase Mandate may be repurchased. As at the Latest Practicable Date, the number of share in issue was 3,116,258,244 Shares. On the basis of such number (assuming no further Shares are issued or repurchased after the Latest Practicable Date and up to the date of passing such resolution), the Directors would be authorised to repurchase a maximum of 311,625,824 Shares.

REASONS FOR REPURCHASES

The Directors believe that having the ability to repurchase shares is in the best interests of the Company and the Shareholders. Repurchases of shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value and/or earnings per share. The Directors are seeking the grant of the Repurchase Mandate to repurchase shares to give the Company the flexibility to do so if and when appropriate. The number(s) of shares to be repurchased, the price and other terms upon which the same are repurchased, and whether shares are to be repurchased on any occasion will be decided by the Directors at the relevant time having regard to the factors and circumstances then pertaining.

FUNDING OF REPURCHASE
