## Election of Means of Receipt and Language of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Bye-laws of Brockman Mining Limited (the "Company"), we write to inform you that you may have in respect of future corporate communications ("Corporate Communications") of the Company, which includes any document(s) to be issued by the Company for the information or action of any holders of its securities, including but not limited to: (a) directors' reports, annual accounts together with the auditors' reports and, where applicable, summary financial reports; (b) interim reports and, where applicable, summary interim reports; (c) notices of meetings; (d) listing documents; (e) circulars; (f) proxy forms; and (g) reply slips.

## You may choose:

- (i) to read the Corporate Communication published on the Company's website ("Website Version") instead of receiving printed copies, and receive a notification of the publication of the Corporate Communications on the Company's website or via emails when the Shareholders provides his or her or its email address in the Reply Form; or
- (ii) to receive a printed English version of the Corporate Communication only; or
- (iii) to receive a printed Chinese version of the Corporate Communication only; or
- (iv) to receive both the printed English and Chinese versions of the Corporate Communication.

To contribute to the protection of our environment and for the purpose of saving printing and mailing costs, we encourage you to select the Website Version. Even if you have chosen the Website Version, you reserve the right at any time by giving reasonable notice in writing to the Company's branch share registrar in Hong Kong, Tricor Secretaries Limited, to change your choice.

Please mark a " $\checkmark$ " in the appropriate box on the enclosed reply form ("**Reply Form**") and sign and return it by post or by hand to the Company's branch share registrar in Hong Kong, Tricor Secretaries Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong on or before 20 October 2023. If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Website Version of Corporate Communications) on or before 20 October 2023, you will be deemed, until you inform the Company otherwise by reasonable notice in writing at the office of the Company's branch share registrar in Hong Kong at the above address or by email to <a href="mailto:brockman-ecom@hk.tricorglobal.com">brockman-ecom@hk.tricorglobal.com</a>, to have elected to receive all future Corporate Communications by Website Version instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send you a notification that the Corporate Communication has been made available on the Company's website. The notification will be sent to you by email and by post at your address as it appears in the Company's register of members maintained by the Company's branch share registrar in Hong Kong.

You may at any time by reasonable notice in writing to the Company's branch share registrar in Hong Kong at the above address or by email to <a href="mailto:brockman-ecom@hk.tricorglobal.com">brockman-ecom@hk.tricorglobal.com</a> elect (i) to receive future Corporate Communications in printed form instead of by Website Version, or by Website Version instead of in printed form, or (ii) change the language in which you receive Corporate Communications in printed form. If you have elected (or are deemed to have elected) to receive Corporate Communications by Website Version and for any reason have difficulty in obtaining access to Corporate Communications on the Company's website, the Company or the Company's branch share registrar in Hong Kong will upon request send the relevant Corporate Communications to you in printed form free of charge.
