On 20 February 2019, the Company executed the Amendment Deeds to extend the maturity date of the 2014 Convertible Bonds by 3 years from 24 June 2019 to 24 June 2022, and the 2015 Convertible Bonds by 3 years from 5 February 2020 to 5 February 2023, in which are subject to independent shareholders' approval. Further details might refer to the announcement of the Company dated 20 February 2019 and the circular of the Company dated 30 March 2019.
