On 30 January 2020, the Company and KGI Asia Limited (the “Placing Agent”) entered into a placing agreement pursuant to which the Placing Agent has conditionally agreed to procure on a best effort basis not less than six places to subscribe for up to 105,264,000 placing shares at the placing price of HK\$ 0.095 per placing share under the general mandate granted to the board of Directors at the annual general meeting of the Company held on 23 May 2019. Besides, The Company is considering a potential share consolidation pursuant to Rule 17.76 of the GEM Listing Rules.
