On 7 February 2020, the Company proposed to implement the share consolidation pursuant to which every five (5) existing shares will be consolidated into one (1) consolidated share; and to change the board lot size for trading on the stock exchange from 2,000 existing shares to 10,000 consolidated shares conditional upon the share consolidation becoming effective. The share consolidation is conditional upon, among other things, (i) the approval by the shareholders at the special general meeting of the Company; and (ii) the Listing Committee of the Stock Exchange granting the listing of, and permission to deal in, the consolidated shares upon the share consolidation becoming effective.
