**INTRODUCTION**

The purpose of this circular is to provide you with information relating to the resolutions to be proposed at the AGM for (i) the granting of the Issue Mandate, the Repurchase Mandate and Extension Mandate; (ii) the refreshment of Scheme Mandate Limit; and (iii) the re-election of Directors.

### GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

An ordinary resolution was passed at the annual general meeting of the Company held on 5 May 2017, the Directors were granted a general mandate (the “**Existing Issue Mandate**”) to allot, issue and deal with new Shares and to exercise the powers of the Company to repurchase issued Shares. The Existing Issue Mandate will lapse at the conclusion of the AGM. The Directors therefore propose to seek your approval of the ordinary resolutions to be proposed at the AGM to grant a new Issue Mandate.

#### **Issue Mandate**

At the AGM, an ordinary resolution as set out in resolution no. 4 will be proposed such that the Directors be given an unconditional Issue Mandate to allot, issue and deal with unissued Shares or underlying shares of the Company (other than by way of rights or pursuant to a share option scheme for employees of the Company or Directors and/or any of its subsidiaries or pursuant to any scrip dividend scheme or similar arrangements providing for the allotment and issue of Shares in lieu of whole or part of the dividend on Shares in accordance with the Bye-laws) or make or grant offers, agreements, options and warrants which might require the exercise of such power, not exceeding the aggregate of 20% of the number of issued Shares as at the date of the resolution granting the Issue Mandate.

Subject to the passing of the resolution no. 4 for the approval of Issue Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the Issue Mandate to allot and issue up to a maximum of 260,223,611 Shares.

#### **Repurchase Mandate and Extension Mandate**

At the AGM, an ordinary resolution as set out in resolution no. 5 will also be proposed such that the Directors be given an unconditional general mandate to repurchase Shares (i.e. the Repurchase Mandate) on the Exchange up to a maximum number equivalent to 10% of the number of issued Shares as at the date of the resolution granting the Repurchase Mandate.

Subject to the passing of the resolution no. 5 for the approval of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 130,111,805 Shares.

An explanatory statement in connection with the Repurchase Mandate is set out in Appendix I to this circular. The explanatory statement contains all the reasonably necessary information required under the GEM Listing Rules to be given to the Shareholders to enable them to make an informed decision on whether to vote for or against the resolution.

In addition, an ordinary resolution set out in resolution no. 6 regarding the Extension Mandate will be proposed to authorise the increase in the total number of new Shares which may be allotted and issued under the Issue Mandate (if the grant of which is approved by the Shareholders at the AGM) by an additional number representing such number of Shares actually repurchased under the Repurchase Mandate (if the grant of which is approved by the Shareholders at the AGM).

### **REFRESHMENT OF SCHEME MANDATE LIMIT**

The Board proposed to seek the approval of the Shareholders to refresh the Scheme Mandate Limit. Under the existing Scheme Mandate Limit of the Share Option Scheme, the Directors were authorized to grant options to subscribe for up to 23,050,219 Shares, representing 10% of the total number of issued Shares as at the date of the annual general meeting of the Company held on 2 August 2012.

Apart from the Share Option Scheme, the Company has no other share option scheme in place.

Since the adoption of the Share Option Scheme and up to the Latest Practicable Date, the Scheme Mandate Limit has not been refreshed and no options have been granted to the Participants, exercised, lapsed or cancelled under the Share Option Scheme.

As at Latest Practicable Date, the Company has thus 23,050,219 options available under the existing Scheme Mandate Limit that may be granted to Participants under the Share Option Scheme, representing approximately 10% of the 230,502,198 issued Shares as at the date of the annual general meeting of the Company held on 2 August 2012.

As at the Latest Practicable Date, the Company had a total of 1,301,118,056 issued Shares and the remaining Scheme Mandate Limit of 23,050,219 Shares represents only approximately 2% of the total number of issued Shares.

The purpose of the Share Option Scheme is to enable the Company to grant options to selected Participants in order to recognize and motivate the contribution of the employees of the Group and to provide incentives and help the Group in retaining its existing employees and recruiting additional employees and to provide them with a direct economics interest in attaining the long term business objectives of the Group.

Pursuant to the Share Option Scheme and in compliance with Chapter 23 of the GEM Listing Rules, the Company may refresh the Scheme Mandate Limit by ordinary resolution of the Shareholders at a general meeting provided that the maximum number of Shares

which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company shall not exceed 10% of the total number of issued Shares as at the date of passing the relevant resolution at the general meeting. Any share options previously granted under the Share Option Scheme or any other share option schemes of the Company (including those outstanding, cancelled, lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company or exercised options) shall not be counted for the purpose of calculating the Scheme Mandate Limit as refreshed.

Notwithstanding the foregoing, pursuant to the GEM Listing Rules, the maximum number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option scheme(s) of the Company must not in aggregate exceed 30% of the total number of issued Shares from time to time. No option shall be granted under any share option scheme(s) of the Company if this will result in the 30% limit being exceeded.

On the basis of 1,301,118,056 issued Shares as at the Latest Practicable Date and assuming that no Shares are issued or repurchased prior to the AGM, the maximum number of Shares which may be issued upon exercise of all options that may be granted under the refreshed Scheme Mandate Limit is 130,111,805 Shares, representing 10% of the total number of issued Shares as at the Latest Practicable Date.

### **Conditions of the Refreshment of Scheme Mandate Limit**

The refreshment of the Scheme Mandate Limit is conditional upon:

- (a) the Shareholders passing an ordinary resolution to approve the refreshment of the Scheme Mandate Limit at the AGM; and
- (b) the Listing Committee of the Exchange granting the approval of the listing of, and permission to deal in, the Shares to be issued pursuant to the exercise of any options that may be granted under the Share Option Scheme under the refreshed Scheme Mandate Limit not exceeding 10% of the total number of issued Shares as at the date of approval by the Shareholders.

Application will be made to the Exchange for the listing of, and permission to deal in, the Shares that may be issued pursuant to the exercise of the options that may be granted under the refreshed Scheme Mandate Limit.

### RE-ELECTION OF DIRECTORS

Mr. Yang Bo (“**Mr. Yang**”) was appointed as an executive Director with effect from 1 October 2017 and Mr. Zang Wei (“**Mr. Zang**”) and Dr. Wong Wing Kuen, Albert were appointed as a non-executive Director and independent non-executive Director respectively with effect from 1 January 2018. Pursuant to bye-law 83(2) of the Bye-laws, the Board shall have the power from time to time and at any time to appoint any person as a Director to fill a casual vacancy on the Board, and any Director so appointed shall hold office until the first general meeting of the Shareholders after his/her appointment and be subject to re-election at such meeting. As such, Mr. Yang, Mr. Zang and Dr. Wong shall hold office until the AGM, and, being eligible, will offer themselves for re-election and ordinary resolutions as set out in resolution no. 2a, 2b and 2c will be put forward to the Shareholders at the AGM.

In accordance with Bye-law 84(1) of the Bye-laws, Mr. Chen Yihua (“**Mr. Chen**”) shall retire from office by rotation. Mr. Chen, being eligible, will offer himself for re-election. An ordinary resolution as set out in resolution no. 2d will be put forward to the Shareholders at the AGM.

Details of the retiring Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

### AGM

Ordinary resolutions will be proposed at the AGM to approve, among other things, the granting of the Issue Mandate, the Repurchase Mandate and the Extension Mandate, the refreshment of Scheme Mandate Limit and the re-election of Directors.

A proxy form for use at the AGM is enclosed. Whether or not you are able to attend the AGM, you are requested to complete the accompanying proxy form in accordance with the instructions printed thereon and deposit the same at the Hong Kong branch share registrar of the Company, Tricor Tengis Limited at Level 22, Hopewell Centre, 183 Queen’s Road East, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for the holding of the AGM or any adjournment thereof. Completion and return of the proxy form will not preclude you from attending and voting in person at the AGM and any adjournment thereof should you so wish.

Pursuant to Rule 17.47(4) of the GEM Listing Rules, any votes of the Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates to purely to a procedural or administrative matter to be voted on by a show of hands. Therefore, the chairman of the AGM will demand a poll for each and every resolution put forward at the AGM. The Company will appoint scrutineers to handle vote-taking procedures at the AGM. The results of the poll will be published on the websites of the Exchange and the Company as soon as possible in accordance with Rule 17.47 of the GEM Listing Rules.

### RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

### FURTHER INFORMATION

Your attention is drawn to the additional information set out in the appendices to this circular.

### RECOMMENDATION

The Board considers that the ordinary resolutions in respect of the granting of the Issue Mandate, the Repurchase Mandate and Extension Mandate, the refreshment of Scheme Mandate Limit and the re-election of Directors to be proposed at the AGM are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of the resolutions to be proposed at the AGM.

**APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE**

---

*This Appendix I serves as an explanatory statement required to be sent to all Shareholders pursuant to Rule 13.08 and other relevant provisions of the GEM Listing Rules in connection with the Repurchase Mandate.*

**THE REPURCHASE MANDATE**

Resolution no. 5 set out in the notice of the AGM will, if passed, give a general unconditional mandate to the Directors authorising the repurchase by the Company of up to a maximum number equivalent to 10% of the number of issued Shares as at the date of the AGM at any time from the passing of the resolution until the conclusion of the next annual general meeting of the Company, the expiration of the period within which the next annual general meeting of the Company is required by the Bye-laws, the Companies Act or any other applicable laws of Bermuda to be held, or at any time when the aforementioned mandate is revoked, varied, or renewed by an ordinary resolution of the Shareholders in general meeting, whichever is the earliest.

As at the Latest Practicable Date, the number of Shares in issue was 1,301,118,056. Subject to the passing of the relevant ordinary resolution as set out in resolution no. 5 to approve the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase up to a maximum of 130,111,805 Shares, representing not more than 10% of the number of issued Shares as at the date of passing of the resolution No. 5, during the Relevant Period (as defined in the Notice of AGM which is set out on pages 18 to 22 of this circular).

**REASONS FOR THE REPURCHASE MANDATE**

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares on GEM. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets of the Company and/or its earnings per Share and will only be made when the Directors believe that such purchases will benefit the Company and the Shareholders as a whole.

**SOURCE OF FUNDS**

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Bye-laws, the GEM Listing Rules and the applicable laws of Bermuda.

**EFFECT OF EXERCISING THE REPURCHASE MANDATE**

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited financial statements contained in the annual report of the Company for the year ended 31 December 2017) in the event that the Repurchase Mandate is exercised in full. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or gearing level which, in the opinion of the Directors, is from time to time appropriate for the Company.

**DISCLOSURE OF INTERESTS**

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their close associates (as defined in the GEM Listing Rules), have a present intention to sell any Shares to the Company under the Repurchase Mandate if the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Bye-laws, the GEM Listing Rules and the applicable laws of Bermuda.

No core connected persons has notified the Company of a present intention to sell any Shares to the Company or has undertaken not to do so in the event that the Repurchase Mandate is approved by the Shareholders.

**TAKEOVERS CODE**

If, as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code.

As a result, a Shareholder, or a group of Shareholders acting in concert (within that term's meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interests, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

In the event that the Directors exercise the proposed Repurchase Mandate in full, the increase in shareholdings of Exuberant Global and Mr. Dai Di in the Company may give rise to an obligation to make a mandatory offer under the Takeovers Code.

For the information that (i) Time Prestige Holdings Limited ("**Time Prestige**") held directly 26,800,000 Shares and Convertible Bonds which can be converted into 134,342,857 Shares upon conversion and (ii) Bustling Capital Limited ("**Bustling Capital**") held directly 67,000,000 Shares and Convertible Bonds which can be converted into 335,857,142 Shares upon conversion. (Time Prestige is wholly and beneficially owned by Mr. Dai Hao while Bustling Capital is wholly and beneficially owned by Ms. Jin Yu. As such, Mr. Dai Hao is deemed to be interested in the 26,800,000 Shares and Convertible Bonds held by Time Prestige and Ms. Jin Yu is deemed to be interested in 67,000,000 Shares and Convertible Bonds held by Bustling Capital. In addition, by virtue of being the spouse of Ms. Jin Yu, Mr. Dai Hao is deemed to be interested in 67,000,000 Shares and Convertible Bonds held by Bustling Capital and Ms. Jin Yu is deemed to be interested in 26,800,000 Shares and Convertible Bonds held by Time Prestige.)
