#### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registry of Companies in the Cayman Islands certifying that the change of name of the Company from “Sino Katalytics Investment Corporation 德泰中華投資有限公司” to “Capital VC Limited 首都創投有限公司” were registered and took effect on 1 April 2010.

However, during conduct of the necessary filing procedures in relation to the change of name of the Company in Hong Kong, it was found that another company (which is unrelated to the Group) with the English name “Capital VC Limited” has already been registered as a Hong Kong company with the Registrar of Companies in Hong Kong. In order to avoid confusions among investors relating to the English name of the Company, the Board has adopted “Capital VC Limited (carrying on business in Hong Kong as CNI VC Limited)” as the name of the Company to carrying on business in Hong Kong, which has been approved by the Registrar of Companies in Hong Kong on 7 June 2010.

#### **CHANGE OF STOCK SHORT NAME**

The Shares will be traded on the Stock Exchange under the new stock short name of “Capital VC” in English and “首都創投” in Chinese with effect from 17 June 2010.

Reference is made to the circular (the “Circular”) of “Capital VC Limited 首都創投有限公司”(formerly known as Sino Katalytics Investment Corporation 德泰中華投資有限公司) (the “Company”) dated 1 March 2010 in relation to the proposed Change of Company Name. Capitalized terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

There will not be any arrangement for exchange of the existing share certificates. New Share certificates will be issued under the new name of the Company.
