**SUPPLEMENTAL PLACING AGREEMENT**

---

**This SUPPLEMENTAL PLACING AGREEMENT (the “Extension Agreement”)** is dated as of 29 September 2022 (the “**Effective Date**”), by and between:

- (1) **CCIAM FUTURE ENERGY LIMITED**, a company incorporated in Hong Kong with limited liability whose registered office is Unit D, 7/F, Seabright Plaza, 9-23 Shell Street, North Point, Hong Kong, whose shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Company**”) and
- (2) **ASA SECURITIES LIMITED**, a company incorporated in Hong Kong and has its registered office at Room 1803-07, 18/F, China Insurance Group Building, 141 Des Voeux Road Central, Hong Kong (the “**Placing Agent**”)

Collectively known as the “Parties”.

**WHEREAS** the Parties entered into a Placing agreement on 5 September 2022 (the “**Original Contract**”), pursuant to which the targeted Completion Date is 30 September 2022.

The Parties hereby agree to extend the term of the Original Contract in accordance with the terms of the Original Contract as well as the terms provided herein.

In consideration of the mutual covenants hereunder and mutual release of obligations under the Original Contract, each of the Company and the Placing Agent mutually agree as follows:

- 1) the parties agree to extend the Completion Date till 14 October 2022;
- 2) the Extension Agreement shall be binding upon, and enure to the benefits of, both Parties to the Extension Agreement and their respective successors or permitted assigns; and
- 3) the Extension Agreement, together with the attached Original Contract, constitute the entire agreement of the Parties hereto in respect of the subject matter hereof, and supersede all prior communications, representations, or agreements, oral or written, by the parties relating thereto.

Save and except for the abovesaid change which will be supplemental to the Original Contract, all other terms and conditions of the Original Contract remain subsisting and unchanged, and the Original Contract shall remain in full force and effect.
