(Hong Kong, 25 July 2012) China Everbright International Limited (“Everbright International” or the “Group”) is pleased to announce that it has secured a household waste-to-energy project in Boluo County of Guangdong Province today (“Boluo Project” or the “Project”) as the bidder with the highest score. The Project marked another foot-print of the Group in expanding the market share in Guangdong Province following its Huidong Waste-to-energy Project. It also strengthens the Group’s leading position in China’s waste-to-energy industry. The total designed daily processing capacity of the Project is 1,050 tonnes.
