WITH ZHUHAI GOVERNMENT**

**STRENGTHENS ITS STRATEGIC INVOLVEMENT IN THE PEARL RIVER DELTA AND
ADVANCES THE DEVELOPMENT OF ENVIRONMENTAL PROTECTION INDUSTRY IN THE REGION**
