

EVERBRIGHT INTERNATIONAL COMPLETES REVERSE TAKEOVER OF HANKORE ENVIRONMENT EVERBRIGHT WATER OFFICIALLY LISTS ON SINGAPORE EXCHANGE

22 December 2014, Hong Kong – China Everbright International Limited ("Everbright International" or the "Group") (SEHK: 00257) is pleased to announce that China Everbright Water Holdings Limited ("CEWHL"), the Group's wholly-owned subsidy, has completed the reverse takeover of Hankore Environment Tech Group Limited ("Hankore Environment") (U9E.SI) on 12 December 2014. Following this, Hankore Environment's stock name on the Singapore Exchange has been changed to China Everbright Water Limited ("Everbright Water").
