

EXPANDS ENVIRONMENTAL PROTECTION MARKET IN HEBEI AND SICHUAN BOOSTS DEVELOPMENT OF LOCAL LOW-CARBON INDUSTRY

18 January 2015, Hong Kong - China Everbright International Limited ("Everbright International" or the "Group") (HKSE: 00257) is pleased to announce that it has signed a strategic cooperation framework agreement with Baoding Development and Investment Co., Ltd ("Baoding Development and Investment Company") in Hebei Province.
